Chemical pesticides maybe part of an IPM program. However, considerable effort is also put towards preventing pest problems by controlling conditions, which may attract and support pests. 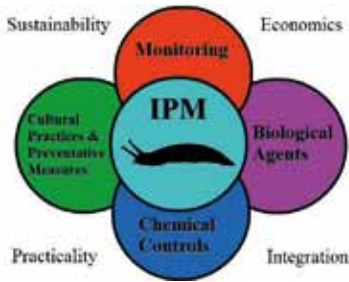
