Voluntary Disclosure Services

A voluntary disclosure (VD) is a form provided by Federal Tax Authority (FTA) to tax registrants to notify FTA about the errors/mistakes and omission/changes in a tax return or tax refund. A VAT voluntary disclosure form 211 in UAE helps a taxable person to correct the errors that occurred while submitting a VAT return or applying for the VAT refund. It gives a choice to the taxable person or business to voluntarily disclose the mistakes that happened in the previous periods.
