

Fire Alarm System

A fire alarm system is a building system designed to detect and alert occupants and emergency forces of the presence of smoke, fire, carbon monoxide, or other fire-related emergencies. Fire alarm systems are required in most commercial buildings and Residential Buildings.





Fire Fighting System

A fire fighting system is a set of interconnected components designed to detect, suppress, or extinguish a fire in an emergency. These systems are typically found in buildings, structures, and vehicles to protect people and property from the devastating effects of fire.

Fire suppression system

A fire suppression system is a group of devices that work together to detect and extinguish a fire. These systems are typically found in buildings, structures, and vehicles to protect people and property from the devastating effects of fire.





Emergency Lighting system

By the nature of the device, an emergency light is designed to come on when the power goes out. Emergency Lighting System plays a key role during evacuation as it highlights the nearest path/door to exit overcoming all chaotic probabilities. Similar to the Fire Alarm System, we offer a wide scale of solutions for the lighting system.

Smoke extracting system

A smoke extracting system is a system of fans and ducts that are designed to remove smoke and other combustion products from a building in the event of a fire. Smoke extracting systems are typically used in commercial and industrial buildings, but they can also be installed in residential buildings.

Smoke extracting systems work by creating a negative pressure in the fire zone. This causes the smoke to be drawn into the system and exhausted to the outside.





Fire Extinguisher
